All students are given exposure to the rigorous Missouri Learning Standards in their core class. The district ensures this by adopting high quality, MLS aligned curricular materials, providing regular professional development and coaching on how to implement the curriculum and providing a crosswalk between the curriculum standards and the MLS. Teachers measure student progress toward the MLS through regular data cycles rooted in the curriculum embedded assessments as well as an interim assessment program through a partnership with The Achievement Network. The district also conducts data step backs based on grade level MAP performance. Students receiving special education services, 504 services, ELL services or other interventions all receive goals that are backwards planned from and aligned to the Missouri Learning Standards to ensure that students in sub populations receive an education aligned to the state standards.

Our adoption of high quality instructional materials, aligned to the MLS, ensures that all students are exposed to rigorous GL standard aligned materials. Our robust Professional Development and instructional coaching models helps teachers over time implement the curriculum with fidelity and effectiveness. Finally, our data cycles and structures help teachers identify students who need additional support to achieve grade level proficiency and sets them up in tier 2 and tier 3 intervention spaces as needed.
